Blockchain isn't one thing; it's an architectural principle

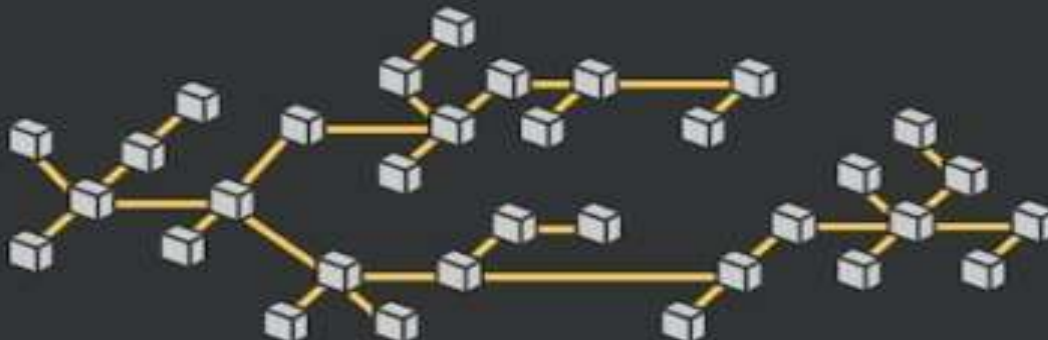
A blockchain is a store of records that is:



✔ Cryptographically secured
(but not, by default, encrypted).



✔ Write once, append only.



✔ Distributed and completely
or partially replicated.

✔ Decentralized, in its pure form.



Blockchain: Anti-Counterfeit “Holy Grail”

- Full supply chain traceability, back to the manufacturer
- Ability to track modifications to the product
- Facilitates importation of equipment from overseas
 - Also helps CBP to target true threats/risks
- Needs participation & cooperation from all stakeholders
 - Manufacturers, resellers, customers, government agencies, regulatory bodies, etc.
- Long way off, but promising first steps
